
Higher Education Division

Professional Development

Woohoo!!!! We are just weeks away from the excitement of another OAEA Professional Development Conference! This is our opportunity to get energized with new ideas, reconnect with old friends, and celebrate the power of art in our and our students' lives.

Attending the Conference offers two ways to earn the Professional Development Units (PDUs) you

need for licensure. You can earn one semester graduate credit from the University of Dayton or up to 2.5 PDUs certified through OAEA. To decide what is the best approach for you consider the following:

University of Dayton graduate credit

Education professionals working toward a master's degree, or a master's +30, may want to attend all two and a half days of the conference and then register their time with the University of Dayton to receive college credit. UD offers one semester credit to OAEA members for \$175.00. If you are interested in receiving credit, check out the OAEA website under Professional Development to find the pdf of the college registration form. Simply follow the instructions provided. Or, if you forget, a copy of the form will be in your conference booklet! Bring the completed form to the registration area during the conference for certification on Saturday, November 7 from 10:00 am - 12 pm. After the conference, the University of Dayton will contact registered members for payment. Remember, you MUST attend all two and a half days of the conference to be eligible for this credit. Also, please remember that if you fill out and submit the form, you are responsible for the \$175.00 cost – NO Refunds once you submit!

OAEA PDUs

Most educators need PDUs to renew or upgrade their licenses. To apply for OAEA Standard Professional Development Units go to the OAEA website under Professional Development and look for Earning PDUs. OAEA will certify up to 2.5 PDUs for full conference attendees and one PDU if you are a workshop presenter (one PDU per workshop regardless of the number of times repeated). Print the form from the website or pull it out of your conference booklet and bring the completed form to the registration area for certification on Thursday or Friday, November 5/6 from 4 – 6 pm or on Saturday, November 7 from 10:00 to 12 pm.

CREATING PERSONAL CONNECTION

This has been an amazing summer of art education for me. I taught a few college classes, worked at the Columbus Arts Festival, trained as a regional leader of Art Education for ODE, and had an amazing experience with our own OAEA President Laura Tawil at the NAEA School for Art Leaders. While at the School for Art Leaders we were asked to reflect on many things, one of them being personal connection. By




making my experience unique to me, I was more invested in the process, had a more authentic connection, and a deeper understanding of the content.

Creating personal connection has long been a goal for the projects we teach at Pickerington. You can teach technique all day, but if the kids are not personally invested, you may not be allowing them a deep understanding of the content. Both the AP and Scholastic Art Awards ask students to create work based on three criteria: originality, technical skill, and personal voice or vision.

So my challenge to my secondary associates at the start of this school year is to take a look at the projects you are currently teaching. Are they allowing personal connections? If they are, can you make it even more personal? If not, how can you make it personal? It can be something as small as having your classic still life project designed by your students with objects they bring in. Have them choose the lighting, the classroom arrangement, and their media choice.

Steve Jobs was quoted as saying, "If you are working on something exciting that you really care about, you don't have to be pushed. The vision pulls you."

Special Saturday November 7 Off-Site Workshop

This year we are offering a special opportunity for a day-long, off-site workshop - Ceramic/Resin Casting: Hands with Kyle Phelps, Associate Professor, Ceramics and Sculpture at the University of Dayton. This workshop runs 8:00 - 11:00 am and continues 1:00 - 4:00 pm; during the lunch break you can return to the Convention Center for lunch. Transportation is on your own (maps provided).

This workshop provides a unique art experience for the participant. You will explore the process





of creating clay/resin cast reliefs (hands). The artist will cover ways to combine clay and resin to create cast positives that do not rely on any traditional firing methods; they are chemically hardened and reworkable. The resulting forms can be cut, drilled, sanded, et cetera, to achieve different textures. A variety of surface treatments including oils, acrylics, stains, and techniques of highlighting, shadowing, and weathering techniques will be demonstrated.

Materials/equipment provided: plaster casting tools (brushes, buckets, shellac, Vaseline, hammers, chisels, paint, sandpaper, clay, drop cloths, and clean up tools). Safety equipment (rubber gloves, dust masks/respirators, safety glasses, and aprons).

The cost is \$30 and limited to 10 participants. Preregistration is required.

Along the way we pulled off the road (literally) to marvel at the unique geography of New Mexico. We returned for the evening orientation that included a clever sticker book ice-breaker activity.

June 19 was spent at the Museum of International Folk Art for the delivery of state reports. Our hosts included a memorable demonstration of red dye and pigment created from the unusual cochineal bugs. State reports concluded on June 20 at the Hilton, which included Ohio. View OAEA's report on the President's page online. (http://www.oaea.org/president-s-page.) Nancy Walkup, NAEA Elementary Division Chair, presented changes in NAEA awards eligibility. The group then divided and rotated around six stations: communications chaired by our own Randy Robart, governance, leadership succession, designing strategic vision, membership growth strategies, and awards. We enjoyed a group visit to the Georgia O'Keeffe museum, a block from the hotel. Nothing beats visiting an art museum with art teachers. The conversations are brilliant. The conference concluded June 21 with review of NAEA position statements and calendar updates on future WR leadership conference locations.

OAEA is a strong presence at our WR events. Our organization is in great shape and has provided leadership to the group and program examples for other states to follow. Be proud to be in the OAEA.

NAEA Inaugural School for Art Leaders Includes Two from OAEA

The NAEA inaugurated their leadership development program July 27-31 at the beautiful Crystal Bridges Museum of American Art in Bentonville, Arkansas. Initiated in their strategic planning and following an investment of significant research and development, the NAEA held a competitive application process last spring to select just 25 scholars for this unique fellowship. The intention of the program is to give participants the opportunity and tools to master leadership style and skills for success.

Matt Young (C), Pickerington High School Central art teacher and OAEA Secondary Division Chair, was honored with selection for the class. So was Laura Tawil (NE), Firelands High School art teacher and current OAEA President. Both benefited from the recommendation and generous support from the OAEA and the Ohio Arts Council. Scholars came from coast to coast and ranged from elementary through higher education/supervision divisions. Assigned to small cohort groups and connected through monthly class webinars, scholars are committed for the next six months to developing individual experiments that "move the needle forward" on their practice. Scholar work will culminate in a final individual case study in December and group presentation at the national convention in Chicago, March 2016. Scholars become part of an emerging network of prepared leaders in the field of art education.

The program launched with a webinar July 1 and an assignment with Dr. Stewart D. Friedman's book Total Leadership. Once gathered in Bentonville on July 27, the class was exposed to more leadership models: Creative Leadership, Emotional Intelligence, Mindful Leadership, the NAEA Competency Model, and the Thurbur-Zimmerman Empowerment Leadership Model. A week was spent in the Crystal Bridges conference room exploring the models through partner, small group and class discussion, meditation, team activities, and mapping and marking journaling. The activities ranged from mindful eating to the spaghetti and marshmallow tower challenge, all with the intent to reveal the connection to internal and external natures and how to negotiate them.

This tailored program was delivered by a dream team of guides: Debra Alvis, a mindful leadership consultant; Elizabeth Guman of Strategy Arts Inc.; Dennis Inhulsen, NAEA Chief Learning Officer; Dr. Robert Sabol, NAEA Past-President; Dr. Renee Sandell, Director of NAEA SummerVision; Niki Stewart, Chief Engagement Officer at Crystal Bridges Museum and Getty Leadership Institute Scholar; and Dr. Enid Zimmerman, professor at Indiana University. Each was an inspiration who shared their leadership story, including their "tipping-point" into leadership.

Amendments to the OAEA Constitution & Bylaws - 2015

With the intention to make the organization more agile and adaptable to the speed of change in the digital age, and to align our policy and practices with our capacity and needs, the Executive Committee put forth a pair of amendments to our constitution and bylaws. These amendments concern our process for making amendments. The proposals were announced at the March and May Board of Directors meetings with board members encouraged to discuss these proposals within their region and division constituents. The language was posted on the website, emailed to members, and delivered in the spring ARTline greater than 30 days ahead of voting. Social media reminders were posted in June and July in preparation for the ballots. Voting online opened July 2, extended, and closed Aug. 2.

With 2% of membership participating in voting, both amendments passed. The amendment to the constitution passed with over \square acceptance of the change and the amendment to the bylaws passed with a majority accepting of the change. Future changes to these documents will now be made at the Board of Directors meetings, voted on by the many Board Members representing you. This will instantly double participation in voting.

A year in the making, this process has not been an easy one. It has revealed areas in our current policy and practice that prolong action and possibly prohibit participation, which your executive committee is passionately moved to improve. With voting now live at the board meetings, we gain opportunities to build procedures for input and discourse.

What this may look like:

An amendment can come from any member, board member, or executive officer. The amendment is forwarded to the Executive Committee. Based on the research, review, and consideration of the Executive Committee, they would determine if the proposed amendment advances to the Board of Directors for decision. The Executive Committee would distribute the proposed amendment to the active voting Board Members no less than 30 days prior to voting, which could be, but is not limited to, a future designated board meeting. A majority vote is required for passage.

Where this leaves opportunity to develop:

- Board Members can activate their regions, divisions, and committees in discourse about amendments at a local and personal level, as all Board Members represent their constituents.
- Development of policy and procedures for member forums and opportunities to participate in OAEA media, publications, and board meetings in new ways.

Attend our annual general business meeting at our conference in Dayton in November. Board of Directors meetings are and always have been open to all members. Join us for the next one in January.

OAEA Constitution

CURRENT Article

ARTICLE VIII - AMENDMENTS

The Executive Committee shall consider and review any proposal for Constitutional amendment and have the final authority to place the amendment on the ballot. Amendments with a ballot shall be distributed to active/retired voting members 30 days prior to the voting deadline. Two-thirds of the votes cast are required for passage of an amendment.

ACCEPTED Article

ARTICLE VIII - AMENDMENTS

The Executive Committee shall consider and review any proposal for Constitutional amendment and have the final authority to place the amendment on the ballot. Amendments notification shall be distributed to active voting board members 30 days prior to the voting deadline. A majority of the votes cast are required for passage of an amendment.

CURRENT Article

The Executive Committee shall consider and review any proposal to amend the By-Laws and have the final authority to place the amendment on the ballot. Amendments with a ballot shall be distributed to active voting members at least 30 days prior to the voting deadline. A majority of the votes cast is required for passage of an amendment.

ACCEPTED Article

The Executive Committee shall consider and review any proposal to amend the By-Laws and have the final authority to place the amendment on the ballot. Amendments notification shall be distributed to voting board members at least 30 days prior to the voting deadline. A majority of the votes cast is required for passage of an amendment.


